As announced, the Province of Nova Scotia has purchased the shares of Bowater Mersey Paper Company Limited. The new Board of Directors of the Company has appointed the Halifax office of Morneau Shepell as the third-party pension plan administrator, effective immediately. We are writing to introduce ourselves, discuss the future of the Bowater pension plans, advise you of upcoming member information meetings, and provide you with our contact information.

# **Future of the Pension Plans**

Given the stated intention of the Province to conduct an orderly sale of the assets of the Company, it is expected that the pension plans will be wound-up in the near future. **Based on the most recent** estimate of Bowater's balance sheet at November 30, 2012, the assets of the Company are sufficient to cover all of the obligations of the Company including the shortfall in the pension plan. As such, the pension plans will be fully funded on wind-up.

Please note that all assets of the pension plans are held in trust by CIBC Mellon for the exclusive benefits of members and former members of the pension plans. The pension funds are NOT available to satisfy any of Bowater Mersey's other obligations.

If you are currently receiving a monthly pension from the pension plans, please be assured that monthly payments will continue to be made.

If you are eligible to retire (age 55) and wish to start your pension, you should contact Morneau Shepell (our contact information is provided at the end of this letter) to request your pension entitlement package.
